MARKETING OF AGRICULTURAL PRODUCTS ACT, 1996 (ACT NO. 47 OF 1996)**CONTINUATION OF STATUTORY MEASURES: REGISTRATION, RECORDS AND RETURNS IN RESPECT OF MAIZE, OILSEEDS, SORGHUM AND WINTER CEREALS**

I, Thoko Didiza, Minister of Agriculture, Land Reform and Rural Development, acting under sections 13, 18 and 19 of the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996),

- (a) Hereby publishes the continuation and amendments of the statutory measures, as respectively published in the Government Notices, as set out in the schedule hereunder; and
- (b) Declares that the said amendments will commence on the date of publication hereof.

SCHEDULE

A. Amendment of the Statutory Measure for records and returns in respect of Maize and Wheat imports and exports

The Statutory Measure for Maize and Wheat imports and exports as published by Government Notice No. 605 of 4 June 2008 (as amended No. 826 of 7 October 2011, No. 68 of 29 January 2016, No. 503 of 18 May 2018, No. 1548 of 29 November 2019, No. 2515 of 23 September 2022) must further be amended as follows:

1. Amendment of returns to be submitted by end-consumers, importers, storers, exporters and processors of maize and wheat.

1.1 Clause 6(3) and (4) is replaced by the following:

(3) The return shall be submitted to any of the addresses furnished on the official return forms to reach SAGIS before the deadline as mentioned in sub clause (1).

2. Commencement and period of validity

2.1 Clause 7: The date of expiry is amended by replacing "30 April 2024" with "30 April 2028".

B. Amendment of the Statutory Measure for records and returns in respect of Maize, Oilseeds, Sorghum and Winter Cereal

The Statutory Measure for Maize, Oilseeds, Sorghum and Winter Cereal as published by Government Notice No. 606 of 4 June 2008 (as amended No. 826 of 7 October 2011, No. 68 of 29 January 2016, No. 1548 of 29 November 2019, No. 2162 of 17 June 2022) must be amended as follows:

1. Returns to be rendered by end-consumers, importers, storers, exporters or processors of maize, oilseeds,

sorghum and winter cereal

1.1 Clause 6 (2), (3) and (4) is replaced by the following:

(3) The return shall be submitted to any of the addresses furnished on the official return forms to reach SAGIS before the deadline as mentioned in sub clause (1).

2. Commencement and period of validity

2.1 Clause 7: The date of expiry is amended by replacing "30 April 2024" with "30 April 2028".

C. Amendment of the Statutory Measure for registration of certain persons in respect of Maize, Oilseeds, Sorghum and Winter cereal

The Statutory Measure for Maize, Oilseeds, Sorghum and Winter cereal as published by Government Notice No. 607 of 4 June 2008 (as amended No. 826 of 7 October 2011, No. 68 of 29 January 2016, No. 1548 of 29 November 2019) must be amended as follows:

1. Application for registration as end-consumer, importer, storer or processor of maize, oilseeds, sorghum and winter cereal

1.1 Clause 6 (3) is replaced by the following:

3) The application form shall be submitted to SAGIS at any of the addresses as furnished on the official application forms.

2. Commencement and period of validity

2.1 Clause 7: The date of expiry is amended by replacing "30 April 2024" with "30 April 2028".

D. Amendment of the Statutory Measure for records and returns in respect of Maize Products and Wheaten products

The Statutory Measure for Maize and Wheaten products as published by Government Notice No. 884 of 14 November 2014 (as amended No. 886 of 24 August 2018, No. 1005 of 18 September 2020) must be amended as follows:

1. Returns to be submitted by manufacturers, importers and exporters

1.1 Clauses 6 (3) and (4) is replaced by the following:

(3) The return shall be submitted to SAGIS at any of the addresses furnished on the official return forms to reach SAGIS before or on the deadline date as mentioned in sub-clause (1).

2. Commencement and period of validity

2.1 Clause 7: The date of expiry is amended by replacing "30 April 2024" with "30 April 2028".

E. Amendment of the Statutory Measure for registrations in respect of manufacturers, importers and exporters of Maize and Wheaten products

The Statutory Measure for Maize and Wheaten products as published by Government Notice No. 885 of 14 November 2014 (as amended No. 886 of 24 August 2018, No. 1005 of 18 September 2020) must be amended as follows:

1. Application for registration as manufacturer, importer and exporter

1.1 Clause 6 (3) is replaced by the following:

3) The application form shall be submitted to SAGIS at any of the addresses furnished on the official application forms.

2. Commencement and period of validity

2.1 Clause 7: The date of expiry is amended by replacing "30 April 2024" with "30 April 2028".

F. Amendment of the Statutory Measure for registration in respect of manufacturers, importers and exporters of Oilseeds products

The Statutory Measure for Oilseeds products as published by Government Notice No. 1153 of 23 September 2016 (as amended No. 1005 of 18 September 2020) must be amended as follows:

1. Application for registration as manufacturer, importer or exporter of oilseeds products**1.1 Clause 6 (3) is replaced by the following:**

3) The application form shall be submitted to SAGIS at any of the addresses furnished on the official application forms.

2. Commencement and period of validity

2.1 Clause 7: The date of expiry is amended by replacing "30 April 2024" with "30 April 2028".

G. Amendment of Statutory Measure for Statutory Measure for record and returns in respect of Weekly Maize, Wheat, Soybeans and Sunflower seed producer deliveries

Statutory Measure for record and returns in respect of weekly producer deliveries. No. 2161 of 17 June 2022 must be amended as follows:

1. Returns to be submitted by end-consumers, exporters with premises and processors of maize, wheat, soybeans, and sunflower seed.

1.1 Clause 6 (3) and (4) is replaced by the following:

(3) The return shall be submitted to SAGIS at any of the addresses as furnished on the official return forms.

2. Commencement and period of validity

2.1 Clause 7: The date of expiry is amended by replacing "30 April 2024" with "30 April 2028".

H. Amendment of the Statutory Measure for records and returns in respect of Oilseeds products

The Statutory Measure for Oilseeds products as published by Government Notice No. 1262 of 14 October 2016 (as amended No. 1005 of 18 September 2020) must be amended as follows:

1. Returns to be submitted by manufacturers, importers and exporters**1.1 Clause 6 (3) is replaced by the following:**

(3) The return shall be submitted to SAGIS at any of the addresses as furnished on the official return forms before the deadline date mentioned in sub-clause (1).

2. Commencement and period of validity

2.1 Clause 7: The date of expiry is amended by replacing "30 April 2024" with "30 April 2028".
