AMENDMENT OF STATUTORY MEASURE

This letter refers to the attached statutory measure as published in the Government Gazette No. 46934 on 23 September 2022.

It is now required that intentions to import and export wheat be declared on a weekly basis.

The above statutory measure is however subjected to certain recommendations from the Competition Commission:

- The volumes of wheat imports and/or exports should be aggregated nationally
- The information of wheat volumes imported and/or exported may be collected and/or disseminated weekly
- The data or volumes of weekly wheat import and/or export must contain information of not less than 5 (five) traders or industry players
- No pricing information be collected or disseminated by SAGIS

SAGIS will treat the data collected strictly in accordance with the recommendations set out by the Competition Commission above.

The first submission date must be 2023/02/20 for the intended wheat imports and/or exports for the following eight weeks.

Please find the attached return form, called "Wheat_Intentions_Return", which must be included as an additional return when submitting the weekly information every Monday before 12:00. The completed return must be submitted at weekly@sagis.org.za.

We would like to thank all co-workers for their continues support and assistance to enable SAGIS to provide reliable data to the industry. Your co-operation in complying with this statutory measure is highly valued.
